




# How We Help

New homebuyers may qualify for various forms of assistance to help with down payment/closing costs, principal reduction and/or interest rate buy down.

Homeownership Assistance Program (HAP)

Through HAP, eligible firsttime homebuyers can receive up to \$5,000.00 toward down payment and closing costs. Annually, more than 50 households achieve the dream of wealth building because of assistance provided by HAP.

Employee Incentive Program Officer Next Door

Eligible employees of the City of Augusta and RSCO can receive up to \$15,000.00 for the purchase of a new or existing home in Richmond County.

Homebuyer Subsidy Program

Homeowners purchasing a unit constructed by our current HOME development partners can receive up to \$25,000.00 in subsidy for principal reduction and/or interest buy down. Teacher in My Classroom

Eligible first time homebuyers who work as an educator with the Richmond County Board of Education can receive up to \$10,000.00 (up to \$20,000.00 if purchasing in the Laney Walker Bethlehem revitalization area) in assistance.

Laney Walker Bethlehem Bond Subsidy

Homeowners purchasing in the Laney Walker Bethlehem Revitalization area, newly constructed by one of our procured development partners, may receive up to \$10,000 in assistance. If purchasing a home in the \$100K Club, homeowners may receive up to \$20,000 in assistance.

\*Each program listed includes certain eligibility requirements and are reviewed as applications are submitted pending availability of funding.\*

# Beyond Purchase

HCD offers a number of programs and resources to homeowners to ensure that homeownership remains affordable and sustainable.

**Emergency Repair Program** 

Through the Emergency Repair Program, eligible homeowners can receive up to \$7,500.00 toward single system repairs (i.e. Roof, HVAC, Electrical)

Code Assistance Rehabilitation Program (CARP)

CARP provides up to \$25,000.00 to eligible owners for repairs that help address code deficiencies and life, health and safety concerns. This program also provides for ADA and accessibility needs for homeowners.

Financial Literacy Program

HCD hosts a variety of workshops and community events geared toward basic financial literacy as an empowerment tool. Student Loan Recovery, First Time Home Buyers and Post Home ownership are a few of the most popular topics covered.
